Dissertation: “Contingency in Leibniz’s System of Philosophical Theology”

Abstract: I motivate a moral necessity interpretation of contingency—which maintains that there is some sense in which God could have done otherwise, even though it would involve a violation of the principle of sufficient reason—as the most promising source of contingency in Leibniz’s system of philosophical theology. I then defend this interpretation against several objections, including objections from divine perfection and divine simplicity.
